

Guidelines for registration in the Tender Procedure Automated System

For participation in tenders and bidding process a Bidder should go through the registration procedure in the Tender Procedure Automated System (hereinafter - the System), by following the link: https://tenders.lukoil.com/sap/bc/bsp/sap/zeng_self_reg/start.htm
